Weekly benefit due surviving spouse at 45% ASW, not to exceed 500 weeks. Weekly benefit due surviving dependent spouse, if there are dependent children: an additional 5% ASW per child, until age 18, and if incapable of self-support after age 18, may be eligible for additional benefits. After the age of 18, if the child is enrolled as a full-time student in any accredited educational institution, or accredited vocational training program, weekly benefits are payable until such child ceases to be enrolled, or the child turns 23, whichever occurs first.
