INDUSTRIAL COMMISSION LUMP SUM SETTLEMENT PROCESSING – CY 21

In CY21 858 lump sum settlements (LSS) were submitted to the Commission for approval. Of these, 855 were ultimately approved, leaving 3 not approved.

The tables below indicate the percentages of LSS approved within each time interval. The number of days is the duration between the date the LSS was received by the Commission until the date it was approved.

Of the 855 LSS processed, only 379 (44%) satisfied the requirements of JRP 18 on receipt. Seventy percent (70%) of the remaining 476 LSS (56%) were approved within 17 days of receipt. Two percent (2%) of all LSS require more than 60 days to approve.

In CY21, 476 LSS were placed on hold at some point during the review process. The tables below identify the reasons causing a hold on the LSS, broken down for both Claimants and Defendants.

The most common reason for placing a LSS on hold is failure to provide information required by administrative or judicial rule, Idaho Supreme Court Opinion¹, or clarification from claimant's counsel. Where Claimant has failed to provide required information the overall average processing time is 17.05 days from the date the LSS was received by the Commission.
