Good afternoon,

I am reaching out to you to see if you have any feedback that you would like to provide to the Idaho Industrial Commission.

From the billing perspective, is the payers not paying on all dates of service on an accepted claim. I have actively started sending disputes to IIC as a way to get payment on the claims that meet the IIC criteria

The other issue is that not all payers will pay on 99212 (suture removal) and many will also not pay on certain DMEs, L-codes and A-codes, despite sending a reconsideration. The payers are still denying them as being billed under a global period for 99212 and an invalid CPT code for the DME.

Please let me know if there is any input we need to address with them.
