**ERRATUM TO
FINDINGS OF FACT,
CONCLUSIONS OF LAW,
AND ORDER**

**FILED MARCH 7, 2025
IDAHO INDUSTRIAL COMMISSION**

On January 23, 2025, the Findings of Fact, Conclusions of Law and Recommendation and the Order were filed by the Commission in the above-entitled case. The parties subsequently filed a stipulation to correct errors in the decision.

Having reviewed the stipulated corrections, as well as the record, the Commission finds typographical errors exist as stipulated. The Commission hereby strikes and replaces the following portions of the decision to correct findings regarding Claimant's left shoulder range of motion and to correctly attribute opinions to Dr. Nielson instead of Dr. Hessing:

1. Findings of Fact, Conclusions of Law and Recommendation, pages 8-9, paragraph 27. The 8th sentence is stricken and replaced with the following: "At this time, Claimant was demonstrating 160 degrees of flexion and 160 degrees of abduction in his left shoulder."

2. **Findings of Fact, Conclusions of Law and Recommendation, page 19, paragraph 78, line 3.** The reference to Dr. Hessing in the second sentence is stricken and replaced with Dr. Neilson.

3. **Findings of Fact, Conclusions of Law and Recommendation page 25, paragraph 107.** The first two words of the first sentence are stricken so that “Dr. Hessing” is replaced with “Dr. Neilson.”

Furthermore, this Erratum’s date shall relate back to January 23, 2025, the date the original Recommendation and Order were issued.
