**ORDER TO SHOW CAUSE**

---

COMES NOW the IDAHO INDUSTRIAL COMMISSION, STATE OF IDAHO, and hereby submits the following for a SHOW CAUSE hearing:

On or about June 22, 2018, the Idaho Industrial Commission entered its Order on Claimant's Motion for Relief and Order to Show Cause in *Sheppard v. Anheuser Busch, and Indemnity Insurance Company of North America*, IC 2009-018074. A true and correct copy of that Order is attached as Exhibit 1 hereto. As set forth in that Order, the Industrial Commission previously concluded that Indemnity Insurance Company of North America (herein after "Surety") is directed to appear before the Industrial Commission to SHOW CAUSE why it should not suffer certain penalties, including withdrawal of its approval to write workers' compensation insurance in this state, for its failure to promptly pay workers' compensation benefits, as detailed in the June 22, 2018 decision. That decision also directed the Idaho Industrial Commission Benefits Department to audit Surety for the purpose of ascertaining Surety's general compliance with the provisions of Idaho Code § 72-301, 72-304, and 72-305, in its Idaho business. That audit has been completed and the audit findings are attached as Exhibit 2 hereto.

Based on the forgoing, Surety is hereby ORDERED to appear before the Commission on

Tuesday, January 8, 2019, at 09:00 a.m. (MST), to SHOW CAUSE why it should not suffer certain penalties, including the withdrawal of its authority to write workers' compensation insurance in the State of Idaho, based on the failures identified in the June 22, 2018 decision and the attached audit.
